Functions and benefits

The Rehab'Impulse Passive Hand is a cosmetic hand made of soft thermoplastic polyurethane. Besides its natural appearance, it allows passive handling and holding of small objects. It is available in two sizes and four colours. The large size is recommended for men while the medium size is recommended for women and adolescents. Both hand sizes feature an M10 interface.

Intended use

This product is intended for prosthetic fitting on adults and adolescents and is exchangeable with a hook or a working ring.

Storage/handling

- Store product in dry conditions
- Store at room temperature (ideally between 15°C and 25°C)
- Keep out of direct sunlight or other sources of light with a high UV content
- Take precautionary measures against sparking and fire
- Keep in original packaging before use



Environmental conditions

Recommended environmental conditions:

- Temperature range for use : -10°C to 60°C (14°F to 140°F)
- Relative humidity 0% to 90%, no condensing situation
- Avoid exposure to dust, sand, salt water, acids and urine

Assembly instructions

Screw the hand into the M10 T-nut of the wrist unit. With the arms resting alongside the torso and hand facing the thigh, ensure that the length is the same as the sound side. Check the functional position of the hand with the elbow at 90 degrees flexion - the hand should be in neutral position (halfway between pronation and supination).

Maintenance

This device is designed for low maintenance. The prosthetic component should be inspected after the first 30 days of use. After this period it is recommended to inspect the device at least every six months for signs of unusual wear. If the device is used in a corrosive environment or subjected to excessive moisture, this period shall be shortened.



Cleaning and care

This device can be cleaned using mild soap or solvent followed by rinsing with water. Allow device to dry completely before use. Avoid strong acid (pH=4 or less) and oxidizing agents.

This device has been engineered for a service life of 3 years depending on user's activity level. Scheduling of regular maintenance lies within the discretion of the service provider. The user shall discontinue use and report to the service provider in the event of any breakage, failure, change in function, or any unusual wear.

Disposal

Users are advised to return defective or worn out products to their clinician.

Please note that disposal of this product with regular domestic waste may not be permitted in all countries of use. Not following the disposal regulations of the responsible authorities may have a detrimental impact on health and environment.

Reusability

This device is intended for single-use only.
